

Dear Sir,

- I, Manisha Agrawal, Proprietor of M/s MA & Associates, Practicing Company Secretary, had been appointed by the Board of Directors of M/s G.K Consultants Limited as Scrutinizer pursuant to Section 108 of the Companies Act, 2013 and read with Rule 20 of the Companies (Management and Administration) Rules, 2014, Regulation 44 of SEBI (Listing Obligation and Disclosure Requirement) Regulation, 2015 and the Secretarial Standard – 2 (SS- 2) on General Meetings issued by the Institute of Company Secretaries of India as amended.
- 2. To Scrutinize the remote e-voting and e-voting at the 34th Annual General Meeting on all the resolutions moved at the said AGM held on Friday, September 30, 2022 through Video Conferencing/Other Audio-Means VC/OAVM, National Securities Depository Limited (NSDL), had provided facility for voting through remote e-voting, for participation in the AGM through VC / OAVM facility and for e-voting during the AGM.



- 3. The remote e-voting remained open from Tuesday, September 27, 2022 (09:00 A.M. IST) and ended on Thursday, September 29, 2022 (05:00 P.M. IST) for the 34th AGM via e-voting platform on the designated website of NSDL, Authorized Agency to provide e-voting facility. The Company provide e-voting facility to the Members who participated/attended the AGM through VC/OAVM to enable such Members to cast their vote, if they had not cast their vote earlier through remote e-voting.
- 4. The e-voting at the 34th AGM was kept open for a period of 30 minutes after the conclusion of the AGM, after which the e-voting was locked by NSDL.
- 5. After the conclusion of the e-voting at the AGM, I counted the votes cast at the AGM and thereafter unblocked the votes cast through remote e-voting and made the Consolidated Scrutinizers' report of the total votes cast in favour or against and invalid votes, if any. Votes cast through remote e-voting were unblocked in the presence of two witnesses, Ms. Sonia Bansal and Ms. Ajita Awasthi who are not in the employment of the Company. 
